Candidate who have passed BFA/BVA in 2023 & 2024 respectively securing 55% of Marks only are allowed to apply. 2. Applicant from other countries must have equivalent certificate from University of Calcutta (Not necessary for Application but should be produced at the time of VIVA-VOCE). 3. A Candidate can apply for single stream only and may not be changed to other stream under any circumstances 4. According to Calcutta University CSR a candidate with break of study for more than three years is not allowed.
